# OICEF Statistics Report

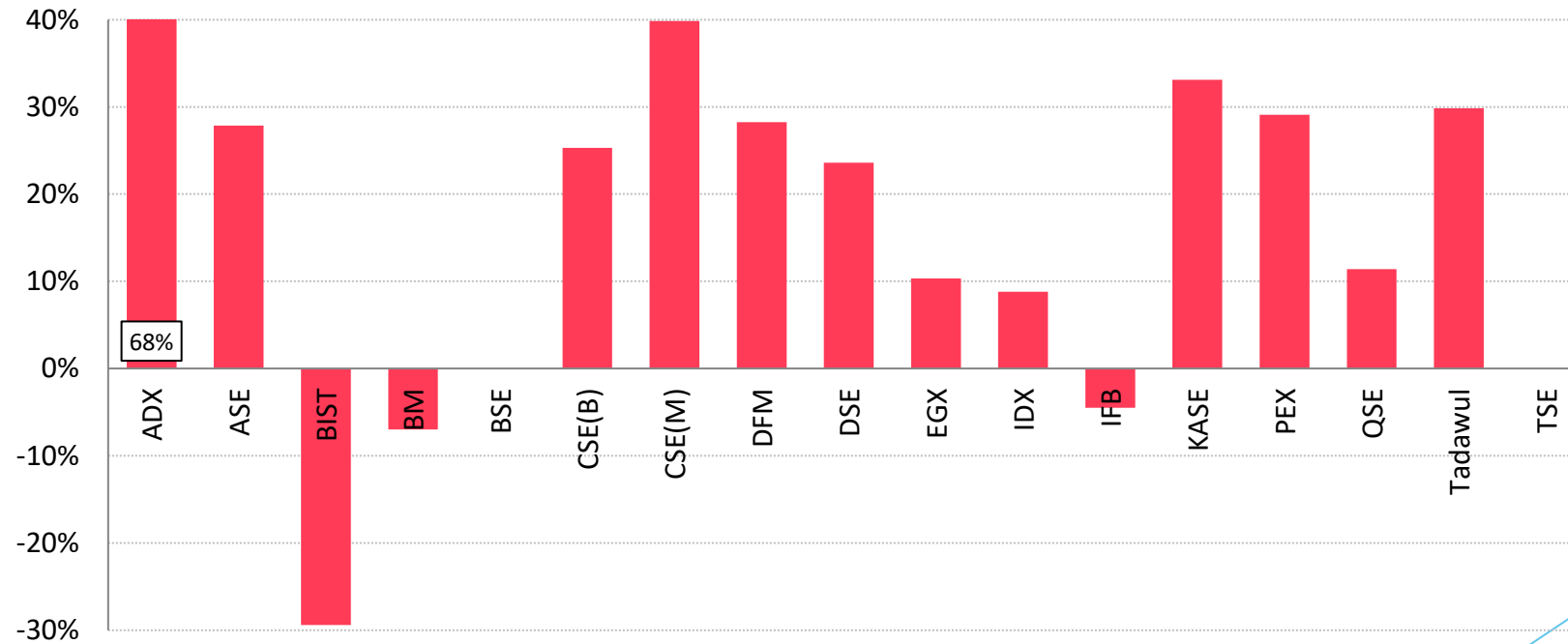
- ▶ Covers organized capital markets

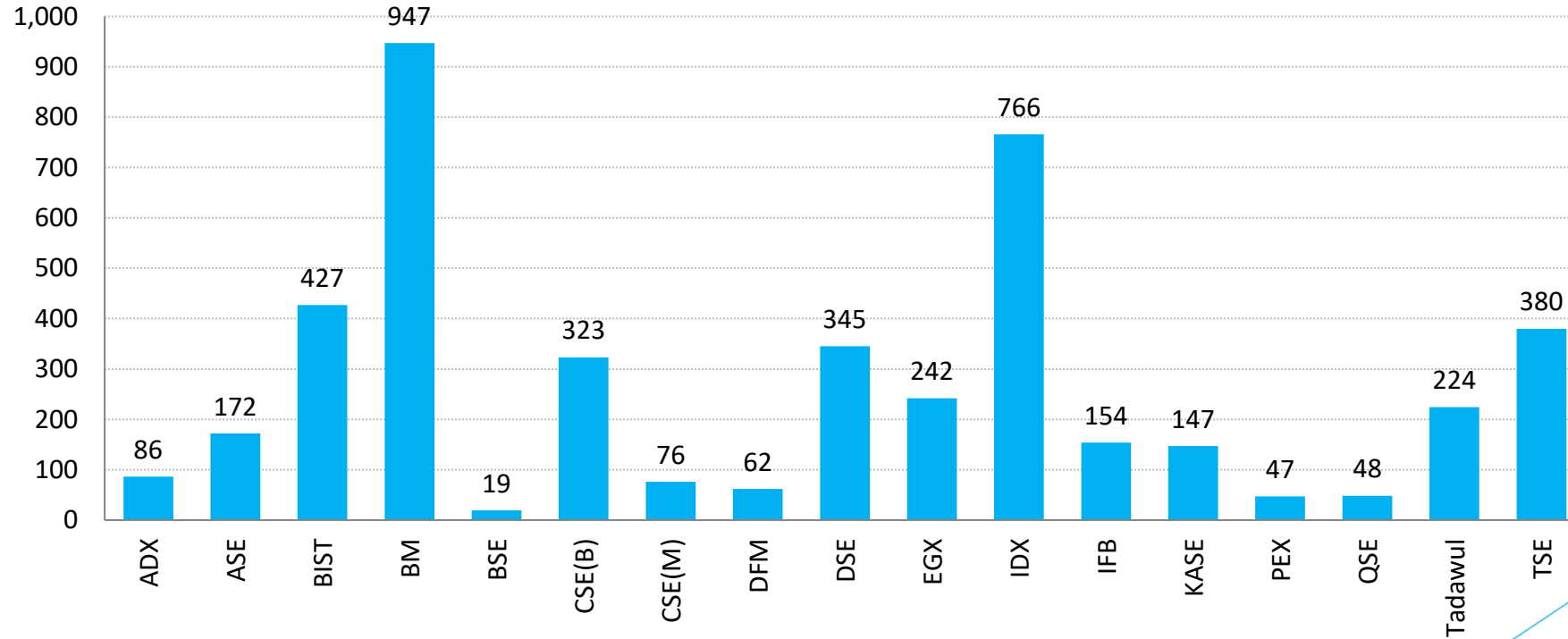
# Benchmark Indices

Value of Benchmark Index (\$), Change from 2020 to 2021

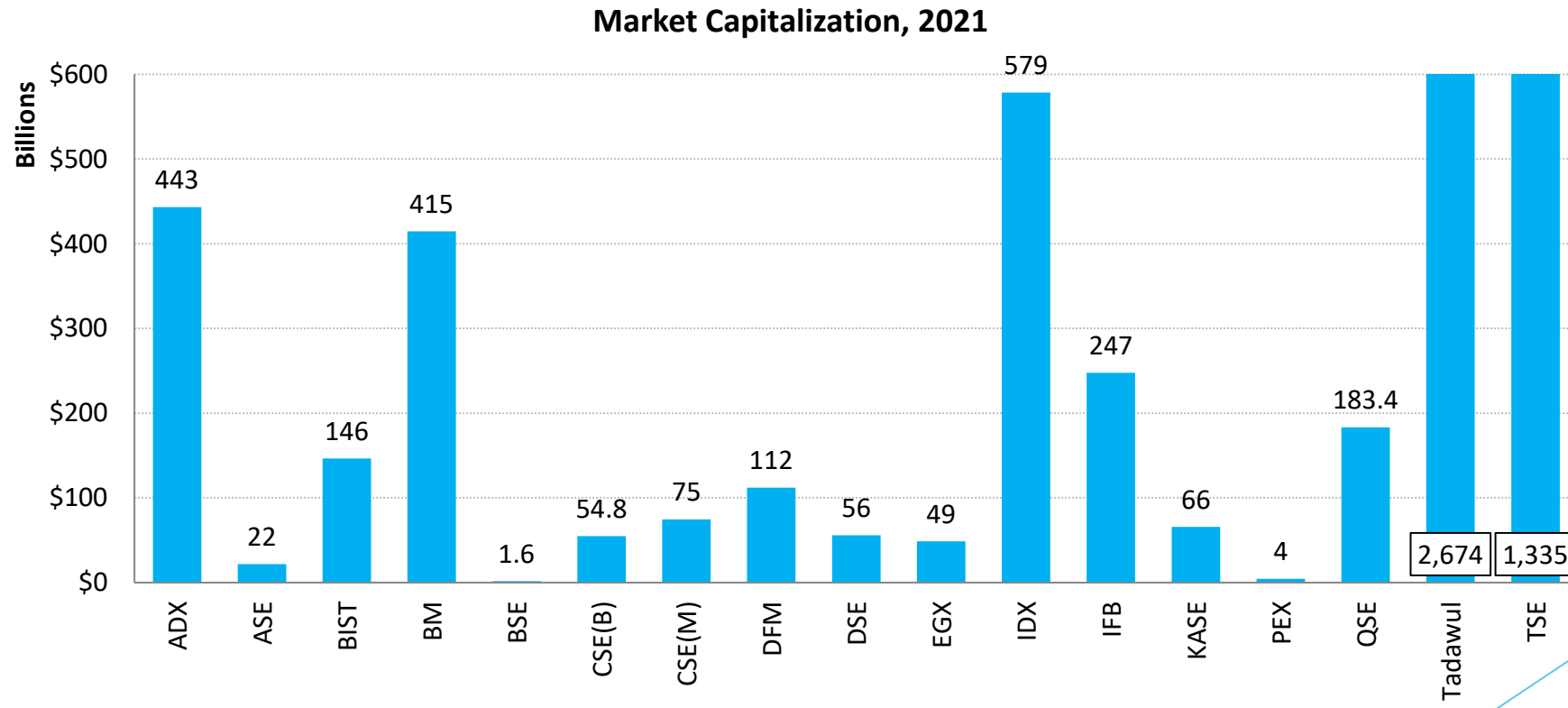


# Number of Listed Companies

Number of Listed Companies, 2021

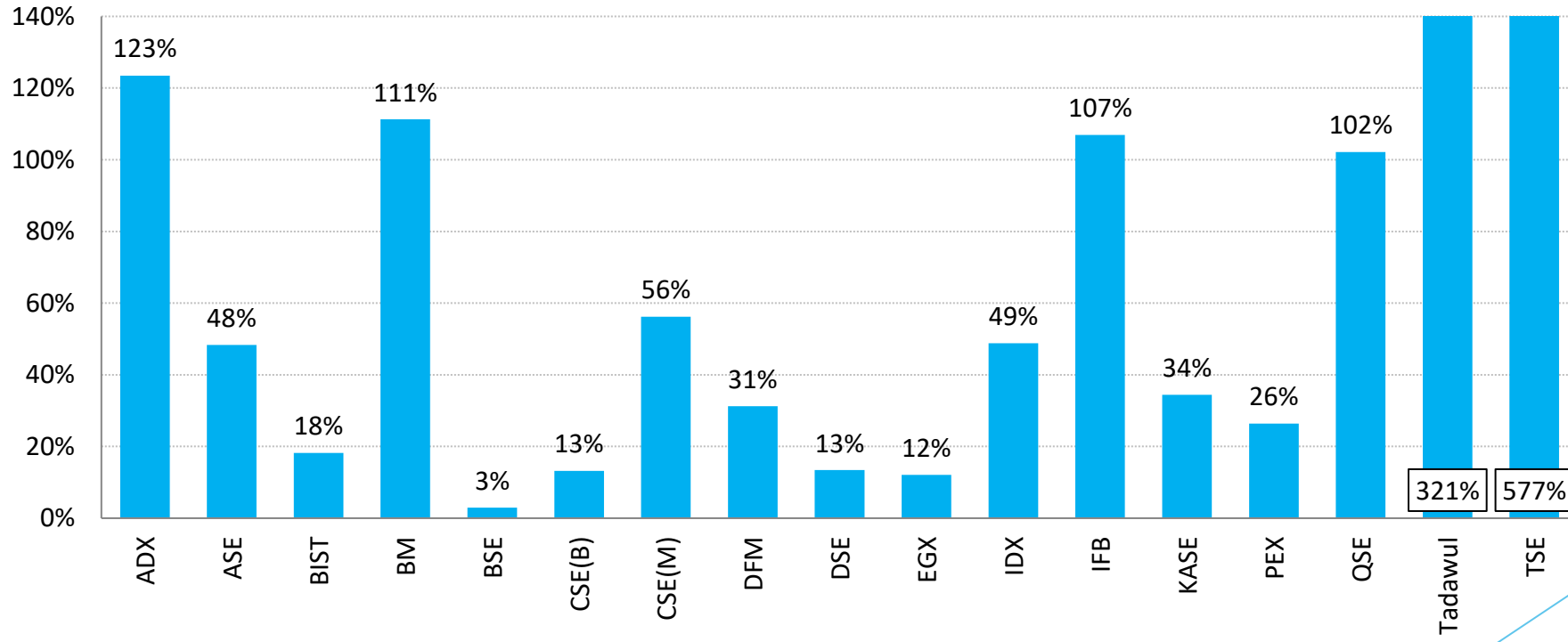


# Market Capitalization



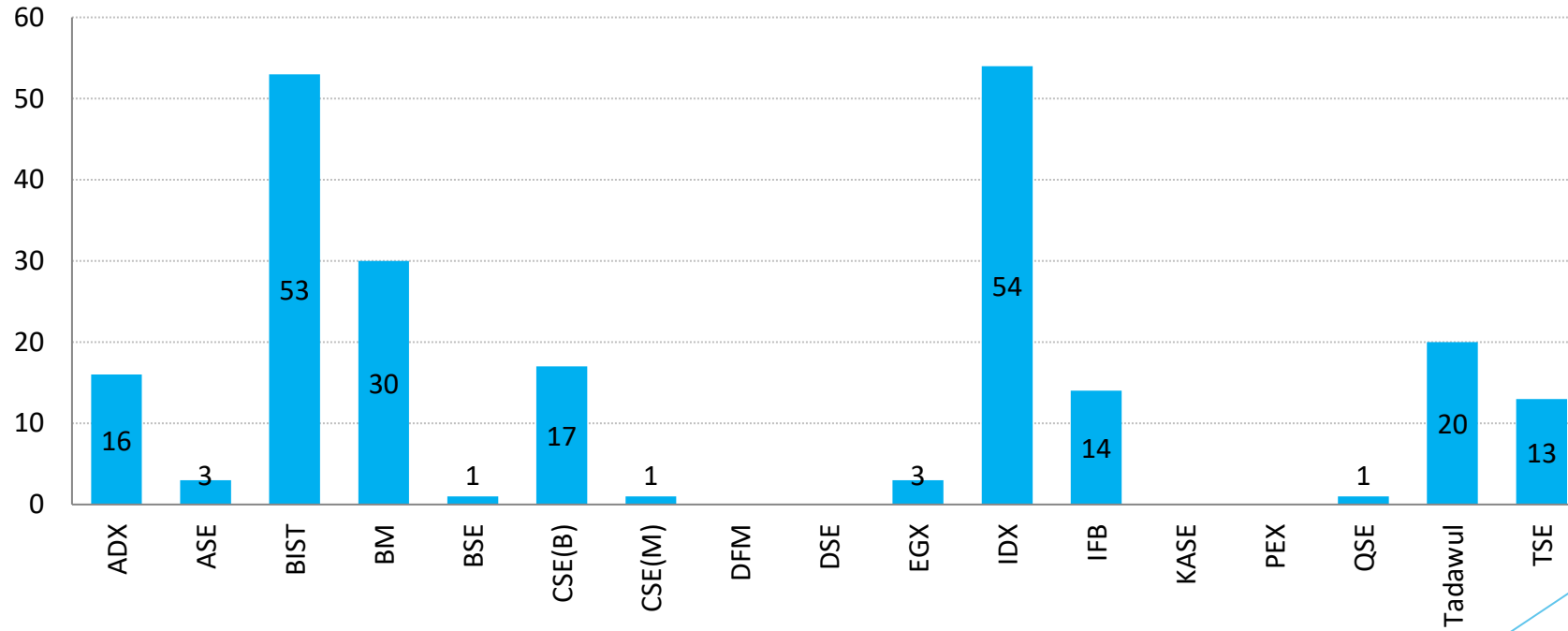
# Market Capitalization / GDP

Market Capitalization / GDP, 2021



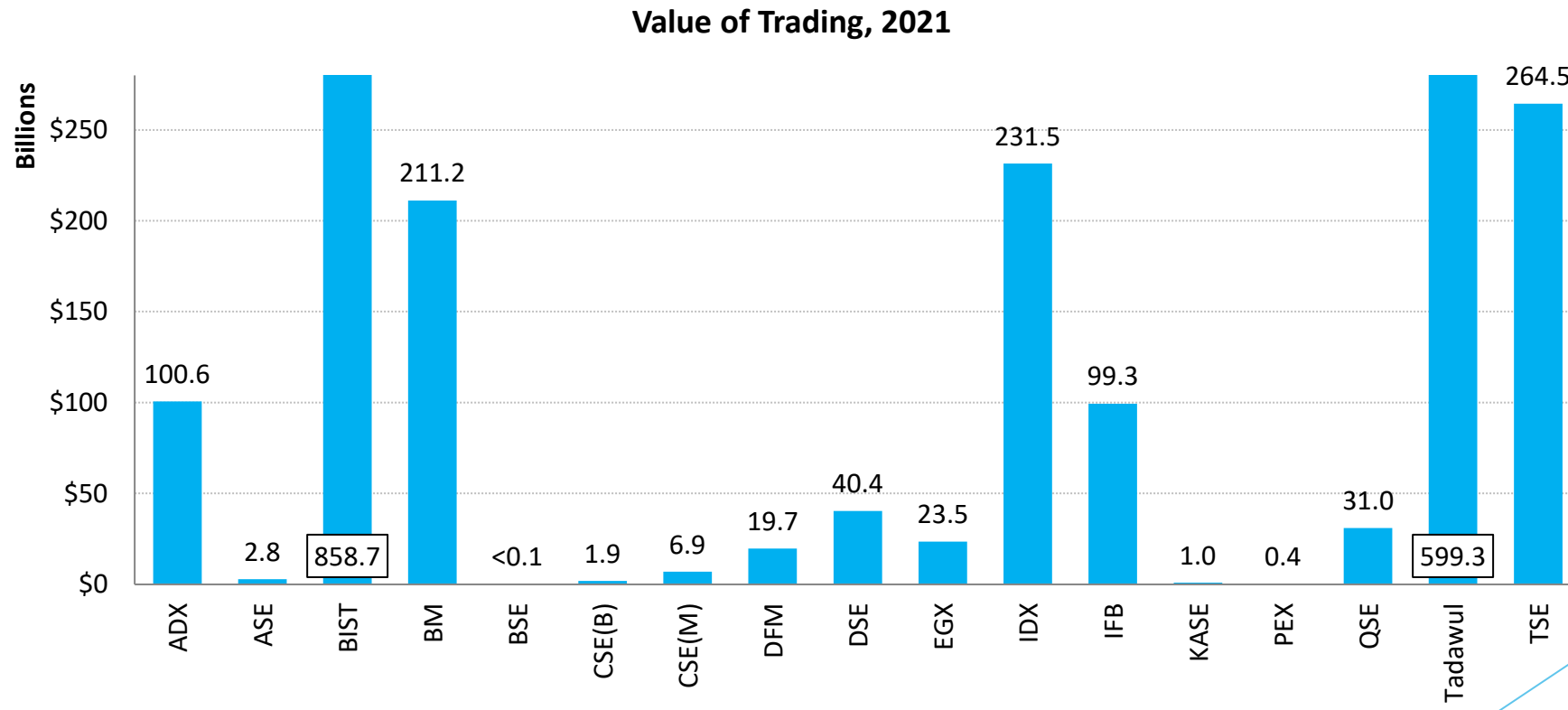
# Number of New Companies

Number of New Companies, 2021



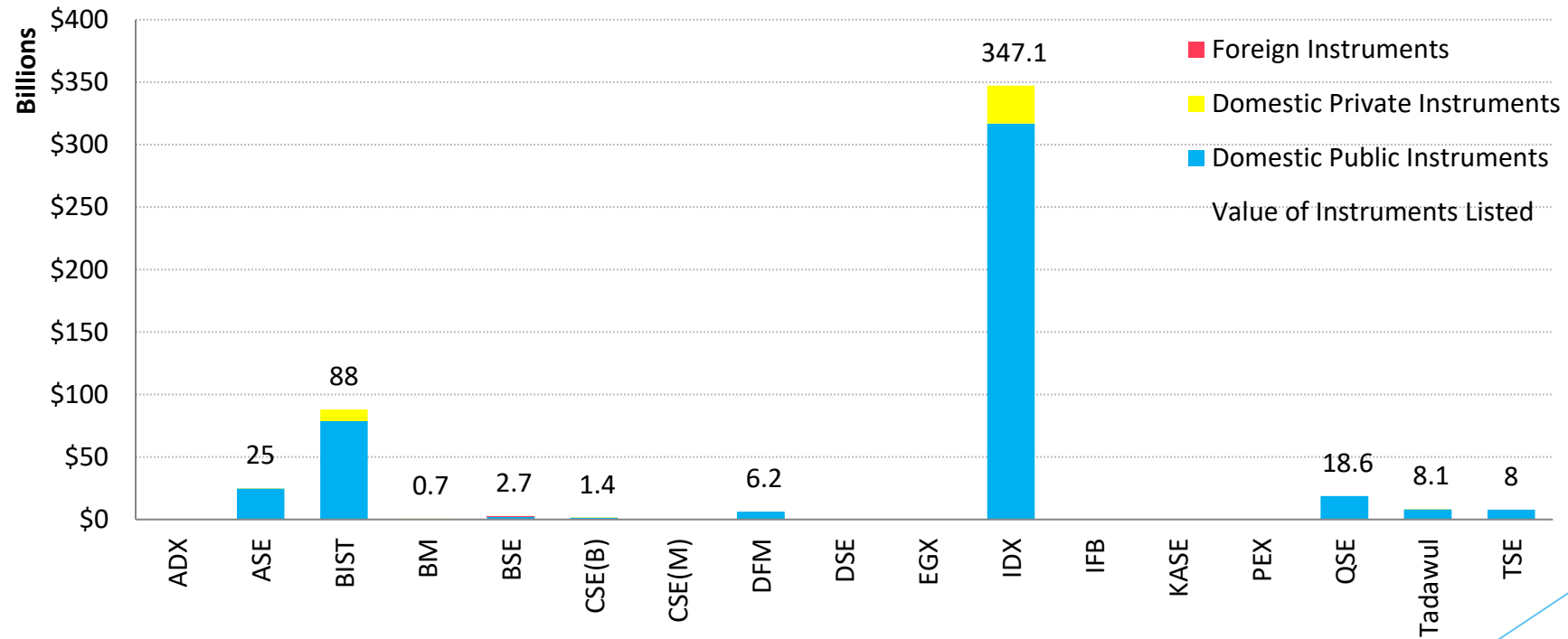

# Debt Securities

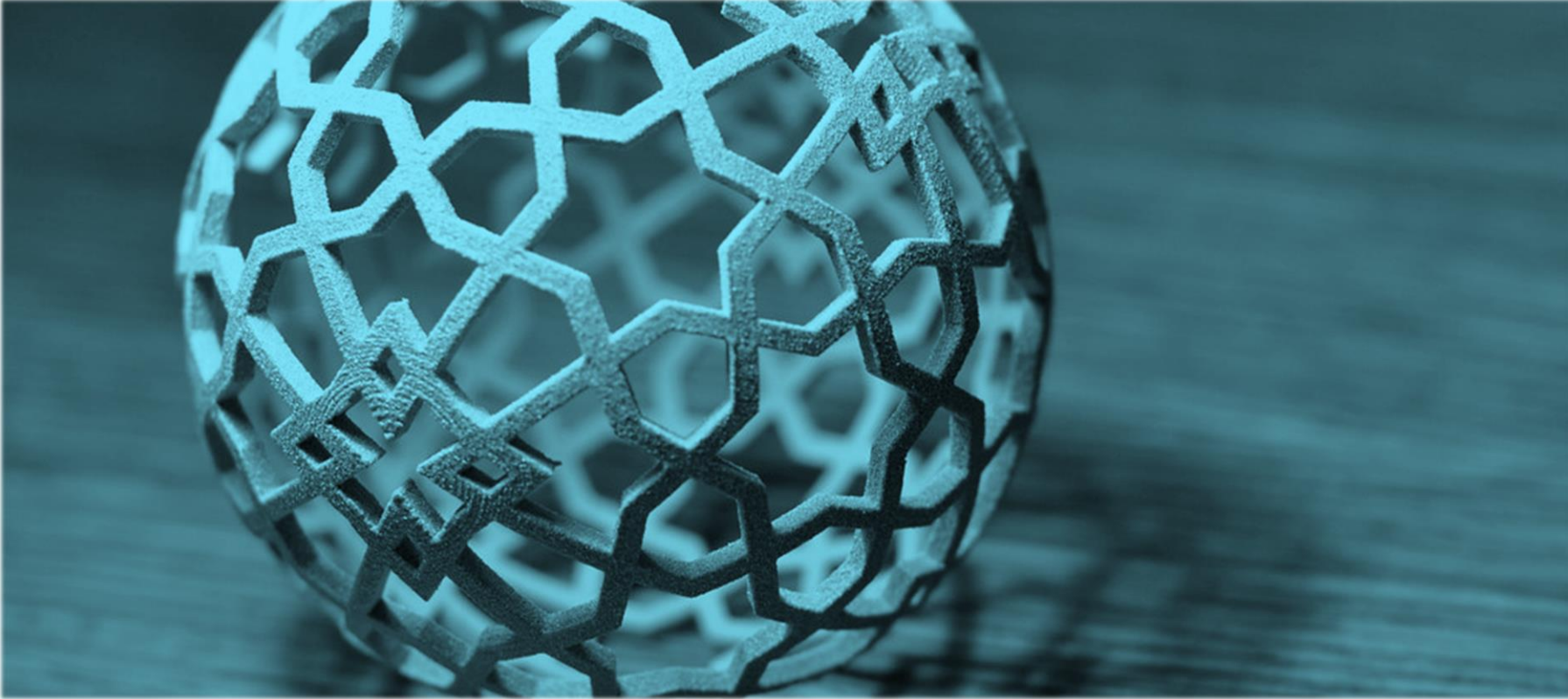
Value of Instruments Listed, 2021





# Sharia-Compliant Securities

- ▶ Based on the responses from 5 Members
  - ▶ Borsa İstanbul
  - ▶ Bursa Malaysia
  - ▶ Chittagong Stock Exchange
  - ▶ Indonesia Stock Exchange
  - ▶ Tehran Stock Exchange
- ▶ There were 1,913 Sharia-compliant shares with a 6% annual increase
- ▶ 380 sukuk products with a 13% annual increase
  - ▶ Outstanding value of \$79.0 billion with an 18% annual increase
  - ▶ Trading value of \$21.1 billion with a 30% annual increase
- ▶ 51 Sharia-compliant funds including ETFs and REITs with a 6% annual decrease
