Aiming to diversify the range of instruments traded, promote the development of derivatives in Indonesia capital market, and increase foreign investment exposure in the Indonesia capital market, Indonesia Stock Exchange (IDX) launched a new derivative product called Foreign Index Futures Contract (KBIA). KBIA will use indices of securities listed on foreign exchanges as its underlying asset. This product allows investors to gain exposure to index movements comprising foreign stocks. IDX has issued KBIA with the MSCI Hong Kong Listed Large Cap index as the underlying. This index represents the movement of large-cap stocks listed on the Hong Kong Exchange.
