

%100 S&P/OIC COMCEC 50 Shariah Index


Asset Allocation



About the Shariah Fund


- The Fund aims to track as closely as possible the returns of the S&P/OIC COMCEC Shariah Index. The fund was established to follow a replication approach meaning that it invests in shares in companies in the same proportions as their weightings in the Index.
- The Index that the Fund tracks is Shariah compliant. The fund follows an investment process that has been approved by an independent Shariah committee.
- The fund attempts to match the performance of Shariah index.
- Minimum 80% of the portfolio is invested in equities.
- The reference currency of the Fund is TRY and USD.
- The Index must include at least one eligible stock from each country. No stock can have an index weight of more than 5%. The aggregate index weight of stocks from any given country cannot exceed 20%. The Index can include no more than eight stocks per eligible country.








